The following documents were received in the office of M/S J. K. Consultancy on 02nd November 2013 for examination and giving opinion thereon.

1. DETAILS OF DOCUMENTS:

- A photocopy of Last WILL & Testament of Mr. Osho containing two pages at stamp paper of Rs. 10/- executed on 15th October 1989 at Poona, India. The questioned signature said to be that of Mr. Osho on the first page of the document is marked as Q1 JKC for the purpose of identification and comparison.
- A photocopy of A4 size document having handwriting and signature of Mr. Osho. The admitted signature said to be that of Mr. Osho on the document is marked as A1 JKC for the purpose of identification and comparison.

2. POINT UNDER ENQUIRY:

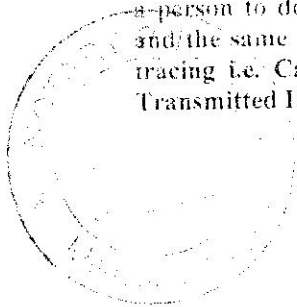
- ✓ Whether the questioned signature of the person marked as Q1 JKC matches with the admitted signature marked as A1 JKC or not.

3. OBSERVATION WITH REASONS:

I have examined all the questioned and admitted signatures thoroughly and carefully with the help of various magnifying lenses, geometrical instruments and with scientific instruments available in the lab at different enlargement and from different angles.

All the questioned and admitted signatures were marked in the office of J. K. Consultancy. The questioned signature marked Q1 JKC appears to be drawn slow in execution, is tremorous in nature and has a defective line quality. Whereas admitted signature marked as A1 JKC is freely written, shows normal consistency and shows genuine line quality.

The questioned signature marked Q1 JKC and admitted signature marked as A1 JKC when superimposed on each other than fit exactly on each other i.e. same in size, shape, slant etc etc which is a sign of forgery as it is not possible for a person to do two exact signatures. These signatures are reproduction of one and the same model. This forgery appears to have been done by any method of tracing i.e. Carbon copy tracing, indented tracing, forgery by tracing paper, Transmitted Image and scanned image etc.

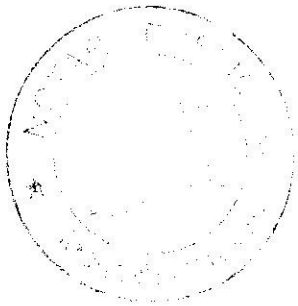

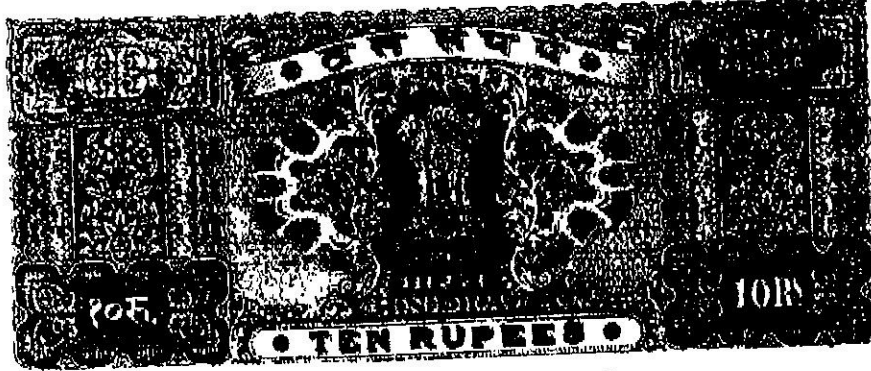

Also in 1981, I executed a broad power of attorney with the stated intention to divest myself of all worldly property, and also an amendment in 1982, with the result that all such property is now owned by Neo Sannyas International Foundation, a Swiss charitable entity. To be completely certain that all such property interests are so divested, I make this Last Will and Testament.

I, Osho, birth name Chandra Mohan Jain, formerly known as Bhagwan Shree Rajneesh, hereby devise and bequest any and all right, title or interest of any nature in any and all property of any nature and in any form, owned by me, now or in the future, including but not limited to, all ownership, publishing or related rights, to all my work, published to date or in the future, in any form, to Neo Sannyas International Foundation.

If for any reason that entity cannot or does not accept this bequest then the alternate beneficiary shall be a non-profit, charitable entity dedicated to the dissemination of my work, such entity to be designated by my executor.

EXECUTOR. I name as my executor Sw. Anand Jayesh, aka Michael O'Byrne.

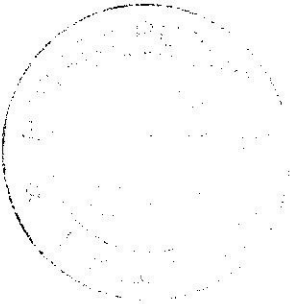

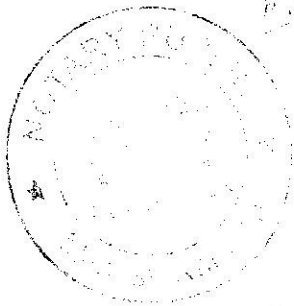
